1. **CALL TO ORDER**

Commissioner Ghio called the meeting to order at 9:01 A.M.

2. **PUBLIC PARTICIPATION**

Chief Morello expressed his support for the awards committee and all the work they do. He does not support the change in procedure and asked Commissioner Ghio to explain the process moving forward.

Commissioner Ghio made a motion TO MOVE AGENDA ITEM #8 UP, Seconded by Jillian Portal.

VOTE: UNANIMOUSLY PASSED

3. **NEW BUSINESS**

Commissioner Ghio explained the change in the process. For example, an award from the March Awards Committee meeting would be approved by the commissioners at the May Police Board meeting, and the actual award would be presented at the June Police Board meeting.

Ofc. Pelletier clarified Commissioner Ghio's explanation, stating that an award from the March Awards Committee meeting would be approved at the April Police Board meeting and presented at the May Police Board meeting. Commissioner Ghio agreed.

DC Osborne advised everyone that the meetings will now be recorded.

DC Osborne read an email from Chief Morello regarding guidance from Corporation Counsel. It stated that a Police Commissioner may designate another Police Commissioner as a stand-in in their absence; only reports, documents, and details that are releasable to the public may be viewed by a Police Commissioner. The use of redactions is appropriate for nomination forms when non-releasable information is contained within them, and any information, including reports, that may be released to the public is perfectly okay to be shared in this forum.

4. **CONSIDERATION OF THE MINUTES**

The officers have been working on it since last fall and have put in a lot of time and effort. Commissioner Ghio asked how often it takes place because he would love to experience it. Ofc. Pelletier explained the schedule.
