REGISTRATION RENEWALS:

1. Application #APA3-2303-01 – Request for renewal of registration of Pit Stop Express Oil Change at 2 Dallas Avenue; Assessor's Map 48, Lot 250; Jaime Cruz, applicant.

Acting Chairman White designated regular Agency Members Marra, Harlow, Gagnon and White to vote on Application #APA3-2303-01. He also designated alternate Agency Member Abrams to vote on Application #APA3-2303-01 with the absence of Agency Member Chair Provenzano this evening.

No representatives were in attendance to present the application to the Agency.

Mr. Armstrong reviewed the request to renew the registration for the Pit Stop Express Oil Change facility located at 2 Dallas Avenue by the registrant Jaime Cruz. He explained the application was complete, but he was unable to answer any questions for the applicant. He explained this was their third registration and Mr. Cruz was the only employee for the facility. He spoke with the representatives from the State of CT and no changes were made to the Materials Management Plan or for any spills or contamination. He explained the registrant reviewed his registration compliance and best management practices and there were no updates. There were no employees to train except for the registrant. There were no complaints reported for the property.

Agency inquiries: Mr. Armstrong explained when he spoke with the State of CT that the registrant would just have to review the criteria again. The applicant submitted a statement that he reviewed the criteria again.

Mr. Armstrong explained there would be no stipulations because the registrant provided two letters stating the Materials Management Plan was complete and that he was up to date on the employee training.

MOTION: move that the Bristol Aquifer Protection Agency accept the renewal of the registration for the following facility in the "Upper White's Bridge/Lower White's Bridge/Mix Street" Aquifer Protection Area as complete, in accordance with Section 8 of the City of Bristol's Aquifer Protection Area Regulations, and in accordance with the plot plan and information submitted.
