Presentation: Amy Martino, Director of Pupil Personnel Services, Bristol Public Schools
Topic: Overview of special services

Ms. Martino began the presentation by introducing herself. She has spent more than 20 years working with individuals with disabilities after having been inspired by a cousin who was blind and deaf.

The Office of Pupil Services has assistants and secretaries to carry out its functions. It has K-12, district-wide programs. The services provided address students with various cognitive and medical needs, including those on the autism

spectrum. There is a desire to keep students with autism in general education classes, but specially designed programs may be necessary. About 122 students with special needs attend out-of-district programs. Preschool services are available as well. Many types of people are involved in programs including teachers, parents, and administrators.

There is much community engagement as well including involvement by MOVIA, CIAC, and the Bristol Blues. The Main Street Foundation has provided grants to support programs. Some of these collaborations include teaching job skills. There are also programs for the 18-22-year-old age group such as assisting with job placement including at Bristol Hospital, Café Real, etc.

Ms. Martino also described various events that have been organized for students in these programs including a reverse career fair and a special end-of-year graduation to accommodate those with special needs.

During the presentation, Ms. Martino answered several questions from commissioners and members of the audience.

- *Chairman Micari stated that he received a call from Margaret Banker, Director of ADA Paratransit Services, Greater Hartford Transit District. She stated that the funding status of the M7 project is in question unless there is funding from the state. A loss of funding could have a significant impact on those who use those services.
