November 20, 2025

I. Call to order

Greg Klimek, Board Member called to order the meeting of the Board of Assessment Appeals at 10:00 a.m. on Thursday, November 20, 2025 at the Bristol City Hall, Meeting Room 1-4 (#107) 111 North Main Street, Bristol, CT.

Roll call

Elect new chairperson

Next order of business was to select a new chairperson of the Board. Greg Klimek entertained a motion to select himself as chairperson of the 2025 – 2026 Board of Assessment Appeals

Thomas DeNoto entertained a second motion to select Greg Klimek as Chairperson of the Board. A second motion was not granted.

Liza Salgado-Sirko entertained a motion to select Ann Marie Heering as Chairperson of the 2025 – 2026 Board of Assessment Appeals. Ann Marie Heering seconded the motion to accept position as Chairperson. A vote was called for Ann Marie Heering as Chairperson. II. Set March and September 2026 hearing dates
